## State Primary Election Annette Tokunaga, Town Clerk

The NH Primary Election will be held on September 9, 2008 at the Veteran's Hall from 8:00 a.m. to 7:00 p.m. People not yet registered to vote may do so on the day of the election. Voters registered as Undeclared may receive either a Democratic or Republican ballot by first stating their party preference to the check-in clerks. Voters wishing to return to Undeclared status should go to the Supervisors of the Checklist table after voting. Voters registered as Republican or Democrat will only be given the ballot of the party to which they are affiliated. The last day to change party before the State Primary was June 3rd. No party changes may be made until after the State Primary. If you will

not be in town on Election Day, you may contact the Town Clerk's office to obtain an absentee ballot. See you at the polls.

#### New Registration Forms Annette Tokunaga, Town Clerk

On June 17th, the State of New Hampshire, Department of Safety delivered a new laser printer to the Town Clerk's office. This was the first step in a statewide implementation of a program to print new vehicle-related forms. Most of the printers were funded through a grant from the University of NH. We expect to begin using the new registration forms in late July or early August.

Following are some changes that you'll notice when you register your vehicle(s). The information on the registration will be arranged in a different format. There will also be a bar code on the new form, which confirms the data on the registration. The carbon-less format has been eliminated. Instead, three copies (one for the State, one for the Town Clerk, one for the owner) will be printed on a tri-perforated, 8 ½" by 11" sheet of paper. As a result, you will need to

## Things from the District July 2008 Jim Carnie and Neil Moriarty

In the Courts The Emergency Meeting Is On. We don't have the details as neither of us has read the ruling; however, the judge ruled (on July 15, 2008 – the day we need to submit this) in favor of the MRSD special meeting to vote on the teacher's contract.

Town of Sullivan Suit for Declaratory Judgment Sullivan's request for Declaratory Judgment (the judge would rule Early Retirement is, or is not legal), has not come up; someone close to the subject has said the hearing will be in September 2008.

**Budgets update OUR (Default) Budget for FY 2007-08.** Your school board could not stop at spending \$500,000 (their agreed amount to spend) of your surplus; it has now spent just

short of \$600,000 of your surplus. We don't yet know the figure on the teacher's contract warrant article however, \$600,000 would go a long way to pay for the first year of it.

**Budget Committee Investigating the Cost Per Pupil** I, (Neil) supplied a quick study, based on NH Dept. of Education figures, showing that our cost per pupil exceeds that of other schools in the area – most outstanding is our high school costs at \$14,000 per pupil (which just happens to be the same as Washington DC). Your budget committee agreed and George Trembley of Troy is going to collect and summarize some background on the whys of our per pupil costs.

Next year's "Surplus" fiscal year 2008-09
Without the ink even drying on this years budget your administration and board are busy seeing

how to spend the health insurance savings (the difference between the not to exceed estimate of November 2007 and the actual billing on May 2008). Basically, these are raises for non bargaining unit employees. While raises may be a valid way to spend a surplus if a surplus does in fact exist in June of 2009 – what happens if something unexpected happens in the next 11 months? Do unexpected things happen? How about the collapse of the home financing market where your house value fell 12% this year? How about gas increasing to \$4.00+ a gallon? Heating oil at \$4.59 a gallon? Yes, Things Happen!!!

Buildings Update Building Plans Middle School
The architect presentation was made on June 15th.
There are many options ranging from about \$26 million to about \$55 million. The latter would be a new middle school and a refurbished high school.
Smaller amounts are also being discussed the latest is what can be done for \$9,000,000? What will be the proposal on the warrant in March 2009 stay tuned...








#### Meadowood Melanie Ellis

#### THIS MONTH'S RSA Terri O'Rorke

As a member of the Rural Preservation Committee (RPC), I've had the opportunity to look up many different land use laws and ordinances. Here's one of interest; TITLE LXIV PLANNING AND ZONING CHAPTER 676 ADMINISTRATIVE AND ENFORCEMENT PROCEDURES Local Conflicts of Law Section 676:14 676:14 Determination of Which Local Ordinance Takes Precedence. Whenever a local land use ordinance is enacted or a regulation is adopted which differs from the authority of an existing ordinance or other regulation, the pro-

vision which imposes the greater restriction or higher standard shall be controlling. Source. 1983, 447:1, eff. Jan. 1, 1984.

#### A Very Human John Adams Frank Behrens

Interest in John Adams, our second president, seems to have reached television back in 1976 when a miniseries called "The Adams Chronicles" appeared on the small screen. This well done dramatization of several generations of the Adams family has recently appeared on an Acorn Media boxed set of DVDs. In 2006, Public Television made "John & Abigail Adams" part of the American Experience series. It emphasizes the relationship between the title characters and lets the historical details speak for themselves. It also is now available on DVD.

In 2008, those who subscribe to HBO viewed a 7-part series named simply "John Adams," based on the book by David McCullough and now available on a 3-DVD set from HBO Video.

The script follows, for the most part, John Adams' point of view. So at the start of the first episode we just miss the Boston "Massacre" and at the end we miss the Boston "Tea Party," because Adams did not witness these events. Indeed, we miss the entire American Revolution, because Adams was doing his job in Europe. So the challenge to the writers was to keep the character interesting enough to hold viewers for three episodes of about 100 minutes each and four of about 80 minutes each. To a large extent, they succeeded.

Paul Giamatti gives us a complex John Adams, a most imperfect man who spent a lot of time worrying about what history would think of him and whose quick temper did little to win the approval of those who lived in his own times. Laura Linney is a most sympathetic Abigail, whose only fault is that trendy way of whispering some of her dialogue to the point of incomprehensibility.

David Morse plays an understated George Washington, except for one telling moment in which he angrily dismisses two members of his cabinet for putting politics before country. What else is new? None of our "great forefathers" were perfect, nor should they be shown as such. Alexander Hamilton (Rufus Sewell) is a warmonger, while Thomas Jefferson (Stephen Dillane) spends a good time of his vice-presidency undermining President Adams and plays the antagonist to Adams' hero.

British actor Tom Wilkinson plays Benjamin Franklin, without the usual "isn't-he-just-wonderful" clichés, as a wily politician who knows how and when to apply pressure subtly. John Adams is too blunt to tolerate that kind of subtle statesmanship, and viewers are left to decide which of the two is right.

Granted the writers could draw upon lots of personal writings from the main players in this historical drama, but one must always be cautious of biased reporting and the fact that this is indeed a dramatization. There are sequences that tend to drag. On the other hand, there is one scene that would have been far better to have occurred off-camera—one involving a primitive bit of surgery with the patient quite awake in these pre-ether times.

One aspect that I found especially annoying was the frequent tilting of the camera to produce some sort of effect: a delicately balanced situation, the world out of joint? The purpose was not clear and the result is predictable after a while and most unwelcome after the fifth or sixth time.

There are the usual bonus features such as "The Making of 'John Adams'," and a look at McCullough as an historian. This HBO set is, all in all, quite a viewing experience and perhaps, one chance in a million that some of the politicians of this day might just try to worry about the country as a whole and not their sacred political parties or most recent pork projects. One can only hope.

He discussed Fay Martin Road and a guardrail that he had put up on the town right-of-way with former road agent Joe Davis' permission. JC advised Alex to call Dana. Lauren Shearer came in to discuss laying out a Class V road on Bowker Road off of Whipple Hill Road. The selectmen requested that Mr. Shearer return with a formal petition. Kim Mattson was in to show the selectmen pictures of runoff from a culvert onto her property. She also raised some questions about two recently demolished structures on Bullock Road. The selectmen will look into this. Andy Wood, Police Chief, came in to discuss some issues in Town. There has been some vandalism on Fish Hatchery Road and Taylor Hill Road. He also wanted to talk about the pistol permit process.
