

Fall Gardening Judith M. Graves

Gardening throughout the year in New England's four seasons is a challenge. Not for the faint of heart, gardening is fast and furious as the seasons change. It seems one day you are looking through your seed catalogues, next visiting the greenhouses, and then you are cleaning out the pots to store for the winter.

September is the time to enjoy such plants as feverfew, baby's breath, tansy, southernwood, goldenrod, chrysanthemums, berry bushes. Beginning now we are raking leaves to add to the compost pile. Swamp maples have turned red, cooler air, gentler sun, and surge of new growth in the garden.

Bring inside the rosemary, scented geraniums, basil, parsley, and other plants you will want on your window sill for fresh herbs all winter long. This is also the time to fill small pots or cans with clips of geraniums for hostess gifts and to give to folks needing a boost in the winter. I like to take a healthy stalk and pinch it to the next leaf. Dip it in a root-tone and put it into the center of a pot filled with fresh new potting soil. Set up a step ladder in the corner of a room and place these pots on the steps. Makes for easy watering, as they are all together, and they are easy to prune and clip as you bring them into beautiful blooms. Plus it is a pleasant look to any room.

Divide daylilies now and phlox once they have flowered. Harvest before frost all your annuals. Continue harvesting others to dry and add to the winter supply. Gather handfuls of goldenrod, (no one is allergic to golden rod. It comes out the same time as ragweed and that is the culprit) zinnias, coneflowers, grasses, and with an elastic gather at the top and hang in a window. When dried gather all the window bouquets and place in a large basket for the winter enjoyment.

Freeze chives, chop basil and parsley to keep the color for winter cooking. Usually, first frost in Zone 5 is October 15th so take in the houseplants before the frost hits. Once the first frost hits it is time to gather the hydrangeas. Place in a basket to dry in place, and hang bouquets of them to later be taken apart to lay in the limbs of your holiday tree. Save one large dried bouquet for the tree top. Beautiful all winter long. I still have a basket 3 years old on the top of a step back filled with hydrangeas that are still so pink; they are beautiful.

October you will enjoy asters, chrysanthemums, goldenrod, sunflowers, autumn colors overnight. Good time to overhaul sections of the garden while still fresh in your mind as still some plants are in place. Or at least take notes.

Hang anti-moth bouquets fresh in your closets. Bunch together strong smelling herbs like Artemisia, mints, rosemary, southernwood, tansy, and with an elastic hang in each closet of your home. It deters moths and keeps your closets smelling awesome. This is always a fun thing to do when you have guests. Give them a pair of scissors and an elastic to make a Closet Bundle to take home; not only fun but something that is remembered and used.

Split all the bulbs, like tulips, daffodils, jonquils now and replant for spring.

Question when to revamp a garden in spring or fall is often asked. In our climate, each season has advantages and disadvantages. The best advice is to do the job when you can, when spirit moves you and you have spare time; true for so much of gardening which is why we all love it. The rules about when to do something applies only if it is convenient. Do the job when you can rather than not at all.

Begin harvesting in earnest. One morning you will wake up and it will be too late. Gather what you will want for winter bouquets, wreath making, potpourris, and your own supplies before you miss it.

My enthusiasm for weeding and tending the gardens dwindles considerably by the middle of October. Beds are often cold and damp from frosty nights, and heavy morning dew. Everything is fading and raking takes priority.

October is the time to plant your narcissus, freesia, and amaryllis bulbs for the holidays. Narcissus bulbs in shallow bowls of pebbles and water, in dark place 50 degrees to root and in 2-3 weeks bring out to stronger light. When shoots are 6-7" put on high bright window not direct sunlight. Display in 5 weeks. Talk about November and December next month. Happy raking...!!!

The Town voted 187 No and 109 Yes to the adoption of the zoning ordinance approved by the Planning Board.


Notes from Town Hall

Selectmen's Office

- Personnel Policies. Last month, the Board of Selectmen adopted personnel policies that apply to all employees. These policies serve as guidelines to insure a workplace free of discrimination and harassment. The general provisions found in Section I also apply to elected and appointed officials, other volunteers who serve the town without compensation, and to contractors and vendors. The remaining policies cover employee classification, compensation and hours of work, including leave time, unemployment insurance, confidentiality, computer and communications use, security, conflict of interest, and standards of conduct. These policies are a work in progress and are subject to modification to stay current with legal requirements and the Town's employment situation. Sections on hiring and termination will be added as soon as they are completed. The adopted personnel policies are effective beginning on October 1, 2010. All employees and volunteer board members have been given a copy. If you would like a copy, please call Roberta Fraser or Bev Hart at 239-4232.

Our employees and volunteers are among the Town's most valuable assets and important resources. We are striving to create a safe, equitable and desirable workplace for our employees and a hospitable place for you, our customers, to conduct your business. - Budget 2011. In the coming months, the annual budget for 2011 will be developed. As you think about how we can improve municipal services for you, our residents, keep costs in mind. We will develop an annual operating budget, but that budget only addresses the day to day expenses of the town. Special reserve and expendable funds address long term needs and plans.

A plan that looks five or ten years ahead is the only way to meet those needs. The town does have a capital improvements program (CIP), which plans for expensive but necessary improvements and capital outlays so money is available for future expenses. Big projects like road repair and reconstruction, construction of a municipal building or rebuilding infrastructure belong on a CIP plan, as do large equipment or vehicle purchases. A strong CIP plan, developed carefully to implement plans by the various municipal departments, can help insure funds are available when needed. Planning is a very important part of making Richmond the place you and your children want to live and we encourage you to share your thoughts and ideas as the budget and CIP plan are developed for 2011.

GOOD NEWS FROM THE DMV

On July 12,2010, I was informed that the State of NH Motor Vehicle Division had changed their policy regarding renewing vehicle registrations. A renewal is when the current registration is about to expire and needs to be reregistered for another year. The State is now allowing non-owners to renew registrations and to *RECEIVE* the renewed registration. For example, a person may bring in the registration for a spouse. The spouse is the only owner listed on the registration. The person bringing in the registration is *NOT* listed on the registration. As long as the owner has *SIGNED* the registration, and as long as there is *NO CHANGE* of information on the expiring registration, the

Special School Election



Cemetery News Continuation

For those of us that like historical or trivia information, the Earl R. Howard Memorial is an extension of South Cemetery located about a half mile from the Four Corner Store on Athol Road. The land was donated by Raymond and Charlene Sexton in 1968 for the purpose as a memorial to Earl R. Howard who originally owned the land and is buried in South Cemetery. Earl R. Howard Memorial was designed as three sections by Harry Bennett while a Cemetery Trustee. Section I was developed and opened in 1975 and now has only 28 plots remaining. Sections II and III were cleared in 2008, and Section III, also known as the Green Burial Cemetery opened the same year with 70 plots. Section II, the largest area required professional help with the

development plan; this was completed last month and has 298 full size plots and 32 half plots.

Earl R. Howard Memorial is a Trust Account Cemetery which means that the sale of the Lots are placed in a trust account and only the interest is used for the maintenance of the cemetery. The problem is that less than \$20.00 has been available for this purpose and therefore, the municipal funds are used for the maintenance of all cemeteries. With the opening of Section II the cost of the plots will now increase from \$25.00 to \$50.00 per plot (one grave site) for town residents and \$400 for non-residents; sale to non-residents will be determined yearly, based on available space. The maximum number of grave sites that can be purchased is three per family. The reason for this limit is to reduce the grave sites that will never be used because the family no longer lives in town. Also, those families that purchase lots will now have 30 days after moving from Richmond to notify the Cemetery Trustees on whether they want to continue to keep their plots or be reimbursed for the unused plots. The additional cost of \$115.00 for Section II is the purchase of corner stones. The cost of the corner stones will be collected with the sale of the lots; corner stones will be ordered by the trustees from Keene Monument who will install them. The exception to this is the sale of half plots for cremations; which can have only a flat stone for identification. The cost of the half plots is \$25.00.

The State of New Hampshire has no requirement for vaults to be used; therefore, they are no longer a requirement for the Town of Richmond. Section II will also allow for Green Burials. The area directly behind Section I and approximately half of New South will be allowed to have monuments and the remaining area will have flat stones only. The reason for this is to reduce the cost of the maintenance.

Section III has 70 plots; the cost of the plots is \$50 for





residents and \$400 for non-residents, sale to non-residents will be considered yearly based upon available space.

Field stones from the State of New Hampshire are the only authorized markers to be used as foot stones and corner markers.

The remaining plots in Section I will now be \$50 each; but corner stones will be optional.

We are in the process of purchasing signs for Sections II and III as well as for Middletown.



SAU Withdrawal vote for Monadnock Withdrawal from SAU 38 for October 26, 2010. By law (Attorney General's office), the withdrawal vote could not be combined with the regular elections. It was reported in The Sentinel that there might be an increased cost when Monadnock (MRSD) withdraws from SAU 38—that is simply not true. The withdrawal committee expects a cost savings

In the first year operating as a separate SAU, we must be conservative (on savings) because of the possible unknowns that might arise. On another positive note, the NH State Dept. of Education (DOE) unanimously accepted, and even recommended that MRSD withdraw from SAU 38; thus the vote above. Ironically, a NO vote on withdrawal (i.e., stay within SAU 38) will actually increase costs of SAU 38; because, Hinsdale is withdrawing (from SAU 38) and you can't cut a staff person in half. Winchester has yet to present their withdrawal plan to the DOE.

Surry is Out of SAU 38. A court ruling (Surry had sued to get out) moved the Surry School District out of SAU 38. It is unclear as to what happens next for Surry.

SAU and Monadnock Organizational Changes. Mr. David LaPointe is our new Facilities Manager. Dave is an alumnus of MRSD and will move back to his hometown of Troy. Dave started September 1,2010 and has jumped in with both feet. Additionally, some requested union/association affiliations additions were approved by the school board.

The All-Day Kindergarten Evaluation Committeemade their report on September 7, 2010 with a recommendation of going forward with fulltime Kindergarten beginning in the fall of 2011. The board accepted the recommendation. The committee stressed the importance of early child intervention as a vehicle to improve overall education for our children. We will report on costs at a later date—the committee did provide a baseline cost and plan; however, their plan is not yet combined with the overall 2011-2012 budget.

High School Renovations *Important Note*: The National Education Association of Schools and Colleges (NEASC) has taken MRSD off probation as far as the facility (high school) is concerned. To accomplish that probation removal, our investment from you, the taxpayer, so far has been \$3 million (projecting another \$2 million, with part of that already collected.) I guess you don't have to spend \$179 million that Newton North High School did, to provide a quality education facility.

With some minor exceptions the high school renovations were completed in time to start the school year. A great deal of credit goes to the custodial staff that had to do a lot of shifting of their summer tasks to work around the construction.

Monadnock (MRSD) Withdrawal

Voting October 26, 2010

The state provides a vehicle (RSA 194-C) for school districts to withdraw from one SAU and to create their own. An SAU being the assemblage that provides administrative tasks for schools, such as, the Superintendent, business administration, human resources, payroll, etc. Voters provided for this process by authorizing your withdrawal committee in March 2010 – a committee was formed, and we both were appointed to the committee. The committee's main emphasis was on improving the education process; mainly, by streamlining the SAU's activity to only MRSD. Under a MRSD SAU each person would be responsible only for Monadnock activity. A vote by the MRSD school board (which meets twice a month) would immediately be reflected in the action of the SAU staff without the delay caused by current SAU process (meeting about quarterly). We expect a very responsive SAU. It is more likely than not that we can run a separate SAU more economically than today's SAU 38 cost. Today we pay 67% of SAU 38 expenses. Just the simple math of paying for one employee (100%) vs. paying for part of two (or more) employees (67% +67%) should see a cost reduction. There should also be savings to be had in not duplicating efforts between the SAU and MRSD itself (most of that savings will be within the MRHS –MS areas.)

The withdrawal committee's entire report can be read at the town library; or, on the Monadnock website (mrsd NH in google) – in the first box WITHDRAW. I (Neil) am trying to get them to put a summary document up there so you don't have drudge through so many pages.

The NH Department of Education (DOE) unanimously endorsed MRSD withdrawal from SAU 38. Your School Board, supports withdrawal; and as three members of the Budget committee were on this committee, we expect strong withdrawal





August Notes from the Town Office

Kim Mattson

This is a response to *The Richmond Rooster's* August issue "Notes from the Town Office" column.

"God vs. The Gavel", by Marci Hamilton, is indeed an excellent avenue to explain Richmond's situation. Thanks to the Selectmen's Notes, August 2010 *Richmond Rooster*. I would suggest that all our neighbors read this very informative book: esp. the chapter(s) on "Religious Land Use and Residential Neighborhoods".

Aug. 3, 2010 I attended a Richmond Planning Board meeting which greatly disturbed me. "Forced acceptance" is how I would describe that evening. As Marci Hamilton explained in her book. "Local Government has found itself quite literally between a rock and a hard place on these issues. These intensely used properties wedged into residential neighborhoods, are often the result of imprudent decision making

by City governments, which follow the tendency of all US politicians, to defer to request by religious entities, without adequate independent analysis. A recent study concluded that it is extraordinarily uncommon for congregations to be denied permission by government authorities to engage in the activities in which they wish to engage."

Marci Hamilton goes on the explain: "It can take little for government officials to be swayed to the religious entities side, especially if the religious applicant pulls the discrimination card. If there is one thing local governments do not want, it is constitutional litigation in the Federal courts accusing them of religious or racial discrimination, and whenever they can avoid it they will. If that means bending the land-use rules to grant a religious entity's request, that is often what will happen".

Through all of Richmond's supposed discrimination and litigation, are the neighbors who must reside as abutters. To quote Marci Hamilton, "When size and intense use combine to affect those who reside nearby, previously friendly neighbors can become hostile enemies. There are two conflicting dynamics happening at once. The religious entity is experiencing a heady and exciting period of expansion, and may well see earthly hurdles as contrary to its divinely inspired religious movement. The neighbors are in a very different place. Typically, they have lived in the neighborhood for a long time, or they chose the neighborhood for its residential qualities, so the new building project is a serious threat to their quality of life. To make matters worse for everyone concerned, a home is often a family's largest financial and emotional investment: thus, when the character of the neighborhood and, therefore, property values are threatened, homeowners understandably object. They really do not care if the expansion project will result in a bakery or a temple. You could be a car dealership, a hospital, a university: It doesn't matter-especially if it is in your neighborhood'.

"Either way, they are losing what they value most in their homes. Yet, given the demographics of religion in the United States, the two sides are almost always religious, so any implied condescension from the leader of the project can really hit a nerve and even a whiff of a holier-than-thou attitude from the members can lead to a conflagration of bad feelings. Conversely, objections by the homeowners are too often translated as somehow anti-religious".

To leave you with one last excerpt from "God vs. The Gavel". "It also cuts to the heart of another cherished American principle: the belief in fair dealing. When churches get special

It is fundamentally unfair to treat property owners in the same location differently because of their identities. It's a gut instinct for Americans, and altering the balance between property owners has been divisive, to say the least.

The real property system in the United States established opportunity and equality. So long as religious entities insist on having special property rights, they will generate the backlash they are just now beginning to comprehend".

"The Mothers-in-Law"

I recall watching a certain sitcom back in 1967 and loving it. Since then, all I can recall is the two female leads standing on stage dressed as Valkyries in the opera of the same name. How happy I was to see that scene again—along with all the other 55 episodes that are now available in a boxed set of 8 DVDs from MPI: "The Mothers-in-Law, The Complete Series."

The basic premise is the relationship of two married couples who are neighbors.

Mr. and Mrs. Hubbard (Herbert Rudley and Eve Arden) have a daughter Suzie (Deborah Walley) who elopes with Jerry (Jerry Fogel), the son of Mr. and Mrs. Buell (Roger C. Carmichael in the first season/Richard Deacon in the second, and Kaye Ballard). Many of the plots are based on the predictable antics of the mothers-in-law trying to run the young couple's lives, others are based on the pattern set by Lucy and Ethel in which idiotic actions lead to farcical situations. (Desi Arnaz is the director, by the way.)

Yes, the humor is that of the late 1960s, when the country was involved in a seemingly never-ending war (don't we ever learn?), and audiences turned to fantasy ("I Dream of Jeannie," "Bewitched," and "The Flying Nun") and broad slapstick comedy. "The Mothers-in-Law" was one of the better new entries in the otherwise barren 1967-68 television season.

It picked up quite a following but was dropped after only two seasons. Arden was her classic satirical self and acted as a buffer for the broader ethnic humor of Ballard, who played the excitable Italian female based (she says in an interview) on her own family background. In the same way, Rudley plays the calmer, more restrained husband to Carmichael's boastful one. Despite Ballard's stated preference, I find Deacon (yes, dear old Mel Coolie from "The Dick Van Dyke Show") much funnier. The actors playing the children are simply bland.

The 1967 colors are garish, the makeup heavy. And along the way, many guest stars do their thing: Don Rickles, Jimmy Durante, and even Desi himself. There are lots of bonus materials on Disc 8 and subtitles.

So for those who seek Nostalgic Silly, this MPI set will provide 27 hours of happiness.


