

#### **Selectmen Minutes Tidbits**

Your selectmen are now Chris Daugherty (term expiring 2018), Carol Jameson (term expiring 2019) and Bill Daniels (term expiring 2020). Chris Daugherty, in addition to being the Chairman of the Selectboard and our ex-officio member on the Planning Board, has primary responsibility for roads. Carol Jameson is Welfare Administrator and Bill Daniels has responsibility for waste management. Your Town Administrator is Heidi Wood and the Administrative Assistant is Susan Harrington.

Work on town buildings continues. The fire alarms in the Vet's Hall have been repaired and painting the remaining sides of Town Hall and the Vet's Hall will begin when weather permits. Emergency generators have been installed at both buildings and will be connected shortly.

Work on grading town roads began later than usual this year due to the Spring rains. We have received several complaints about the condition of the roads after the winter, the period before grading could start – more complaints about potholes this year and less about mud, again weather related since this (and not the mud season) was the main problem this year. We received requests for temporary fixes to the roads as an interim measure. We are looking into this and, if research warrants, we may recommend a separate warrant article next March in order to let the voters decide whether the expense of temporary fixes is worth doing.

The Selectboard is forming an ad-hoc committee to investigate educational alternatives for students from the Town of Richmond, which will likely have been formed by the time of this printing. Richmond currently pays approximately \$1.4 million dollars to the Monadnock Regional School District (MRSD) for approximately 140 students from town to attend K-12 schools in the district. Many residents have expressed concern regarding the amount and percentage of their tax bill that is paid to the district, and some have expressed concern regarding the future of the district since several

district towns have already withdrawn from the district and others have expressed some level of interest in withdrawing. We have invited Richmond residents Jed Butterfield, Peter Mulhall, and Doug Bersaw, all of whom have experience in the field of teaching and/or administration of schools, to serve on this committee. We are also looking for a parent of an MRSD student to serve on the committee. After the committee has a chance to finish its study and present the results of its research to the Selectmen, we anticipate presenting the results to the public and investigating, based on the findings of the Committee and the public interest and response to the findings, whether further action or further research is warranted. Given the level of current dissatisfaction with the district, we feel that it is time for us to become active participants in understanding the current situation and evaluating alternatives. Our children deserve it.

The Police Department has gone through a few changes over the last few months. Andrew Wood has taken over the operation of the PD. Andy has been the full-time Chief of Police in Hancock for the last 8 years. He has continued to work for the Town of Richmond and had held the rank of Chief of Police from 1999-2012. The department continues to search for qualified people to fill vacant positions, Cam Prior has been with the department since June of last year. Amanda Swanson was recently hired as the newest officer in Town. Mandi is an officer in Rindge and is currently attending the New Hampshire Police Full-time Academy. She has been a part-time certified officer in NH for over 2 years. Administrative Assistant Lynn Adams, one of the towns longest employees, continues to assist citizens at the police department 3 days a week.

I would like to remind everyone that June 30 is the deadline to mail the DP-8, Low and Moderate Income Homeowners Property Tax Relief form. You may qualify for tax relief from the State if you were single and earned \$20,000 or less, or were married and earned \$40,000 or less in 2016. Forms are available at the Town Hall and on the State website at www.revenue.nh.gov. The forms must be postmarked by June 30.

## May Update

## Jim McConnell – State Representative Cheshire 12 – Richmond and Swanzey

This past month the House has been busy completing work on the bills which have passed the Senate and been sent to the House, reconciling differences between bills passed in both bodies, but amended in the Senate and attempting to resolve the problems with the budget.

As I mentioned in last month's update, I have been deeply involved in discussions on the budget. Following the budget's failure to pass the House, the Senate Finance Committee heard from the House Finance Committee and, taking that, and the Governor's proposed budget as rough starting points, has begun to craft its own proposal.

My concern continues to be that permitting the General Fund to increase by double digits is irresponsible. The General Fund is that portion of the budget which we have the most control over and the basis for most of the State's portion of our taxes. My desire is to see our General Fund's increase capped at 3% without

any downshifting of expenditures to counties and municipalities to reach that 3%. Any additional revenues after that 3%, should be used to reduce taxes and debt. Our taxes and debt are already too high, and continued profligate spending can only drive taxes and debt higher. Happily, a significant number of House members share this view. It should be noted that most of our budget is either Federal Funds or other dedicated funds, such as Highway Funds, Turnpike Funds, and the largest category of all, the miscellaneous category of Other Funds.

The most recent annual Tax Foundation analysis notes that New Hampshire is now the seventh worst state in the nation in State Debt per Capita. Last year we were eighth.

On a happier note, I am pleased to report that Senate Bill 128, which would have undermined the utility restructuring law (RSA 374-F), was retained in the House Science, Technology, and Energy Committee, and is almost certainly not going to be further considered. This bill would have subjected electric ratepayers to the risk of stranded costs, and permitted utilities to petition the Public Utilities Commission to permit uneconomic projects to proceed underwritten by electric ratepayers. I fought this bill in both the Senate and House, and am relieved to see it defeated.

# **Things and Thoughts from the District** – Neil Moriarty

**1. Progress Made:** Deleting Paragraph Nine of the policy prohibiting Free Speech of Board Members Disagreeing with the Opinion of the School Board.

After a general vote against deleting the paragraph at a prior School Board meeting, the Policy Committees recommended that the Board agree with the voters, and to delete the paragraph (March 2017 Public vote). They did add a statement in the policy asking the Board member to claim that the opinion given was their own and not that of the Board. This policy update was presented by the Policy Committee as the first (of two) reading at the May 2, 207 Board meeting. There was no discussion for, or against, the proposed change.

*Note:* In the May 2017 *Rooster* I used a disclaimer to reflect that my article is mine alone unless I say otherwise. From now on, I have added that disclaimer to my closing standard paragraph. Unlike some newspapers, I don't feel it is necessary to repeat that disclaimer every time it could possibly be applicable.

## 2. "America Reads" Donates Books to America Reads Volunteer's Students

I gave out 24 new books to each student and classroom (one each) where I volunteer. "America Reads" does that for every student and classroom where there is an "America Reads" volunteer. The following week, I gave each kid another book that I purchased from the Richmond Library. The price at Richmond Library is very fair and I don't mind doing it; however, if you want to contribute, buy the book from Wendy and have her put it aside for me.

3. Late Bus Discussion – Middle/High School Parents please READ. The topic of reducing the late bus to one or two, and then only to have single drop off point per town, is under discussion. The single Richmond dropoff is under discussion as being the Four Corners (intersection of routes 119 and 32); while I spoke against this idea being adapted, at all. I'm sure parents would prefer the single drop be the Veteran's Hall. Parents could refuse to let their kids use the late bus at all, then no drop-off issue. Unsupervised drop-off points in the dark of winter especially concern me. Could we afford to pay the library for 3 more days, to be open from 3 to 7pm (times subject to change, and Wendy's availability)? Could someone volunteer to be at the Veteran's Hall for the drop off? Who is responsible if a kid gets dropped off, and is not picked up, or worse?

## Heritage Commission at Work

The Richmond Heritage Commission has continued its work throughout the winter, developing plans for 2017 activities and building collaborations with town volunteers and the Board of Selectmen to help carry them out. The arrival of spring has jump started landscaping activities in areas where our members and volunteers established gardens in the recent past. These include the Town Hall, Town Well and Memorial Watering Trough, Tramp House, and Library. These spaces have already been cleared of leaves, fallen branches, acorns, pine needles and other winter debris. Carol Jameson (Chairman of the RHC), Jan Weekes (both Master Gardeners in their own right), and Mallory Reese have planted, trimmed, and weeded these areas, and developed plans for their continued enhancement which will include adding flowers, bushes and trees where needed. This work is funded by the Richmond Heritage Commission.

The town has already developed plans to have the site around our historic Veterans Hall stumped and graded for planting later this year, and increasing the size of the parking area. The Heritage Commission plans to work on landscaping the area immediately surrounding the Vets Hall, formerly the First Universalist Society Meeting House built in 1837. Working in collaboration with volunteers from the Richmond Historical Society, we also plan to develop a long range plan for improving the Memorial Park, adding to the existing American Revolutionary War monument honoring Richmond veterans who served in later wars, using funds donated for this work.

To date, the Heritage Commission has replaced the badly damaged roof and floor of the Telephone Building to the south of the Vets Hall, and restored and painted some of its Greek Revival trim. Work will continue this spring to replace the door and door frame and interior sheetrock. When finished, Heritage Commission members will paint the building inside and out and work on appropriate landscaping to the surrounding area.

Over time, this area in the center of town, which is now an eyesore, would then have a much improved appearance, setting off the Vets Hall, the circa 1938 Telephone Building and a redesigned Memorial Park.


In addition, work will go forward on turning a small area on the northeast side of the 4 Corners, located on the front lawn of Ed and Melissa Atkins' house, into a landscaped space commemorating that location as the site of Richmond's original Town Common. An antique iron pump will be installed on top of the existing town well together with signage noting its past history and honoring longtime Richmond resident, Gerry Brewer, who lived there. The Heritage Commission is deeply appreciative of Ed and Melissa's, and the entire Brewer family's willingness and help to complete this project.

Finally, the Heritage Commission would like to say thank you to town residents who approved an allocation of \$1000 at town meeting to help fund Heritage Commission activities in 2017. As you might expect, the work we are engaged in, that of preserving and properly presenting Richmond's colorful past for present and future generations of residents and passersby, will require substantial additional funds. These we work hard to raise behind the scenes, relying on those who value our history and wish to strengthen town pride.
